**PRIVATE INTEREST** is defined as *"Employment, board membership, or participant in the management and/or operations of an entity."*

If you or any member of your family has any **FINANCIAL OR PRIVATE** interest AND your actions, decisions or recommendations could benefit that interest, it must be disclosed below.

**UNEMANCIPATED** is defined as *"a minor who is not yet free from the care and custody of parental control due to being under the age of majority, unmarried, not in military service, and not declared emancipated by court order. The age of majority is 18."*
